- ◆ *Aegis Insurance Services v. General Electric Company*, Tenth Judicial District of Minnesota. Secured complete defense verdict in \$173MM+ commercial property damage case involving claims stemming from the catastrophic failure of a large coal-fired steam turbine. Case affirmed on appeal.
- ◆ *Hamid Abbasi v Leading Edge Aviation Services*, United States District Court for the District of Minnesota. Hull loss involving Cirrus aircraft incident. The pilot lost control when the flaps malfunctioned on approach to landing. Aircraft was declared a total loss as a result of the damage sustained during the deployment of the ballistic parachute on the aircraft. Summary Judgment granted in favor of aircraft maintenance facility, who had replaced the flaps 18 months earlier.

Aircraft accident case involving four fatalities. Obtained dismissal of propeller overhaul facility in pilot's wrongful death case, based on Minn. Stat. § 544.41.
- ◆ *Monahan v. National Presto Industries, Inc.*, United States District Court for the Northern District of California. Product liability case involving burn injury from deep fat fryer. Jury verdict in favor of product manufacturer.
- ◆ *J. Render v. J. Prins*, State of Minnesota, County of Hennepin, Fourth Judicial District. Obtained jury verdict in favor of plaintiff real estate financier, after default by borrower.
